12 **Supplemental Covenants**

13 3.1 Annexation. The original Declaration of Covenants, Conditions and
14 Restrictions for Crystal View Estates provides that the Developer may annex to the original
15 property additional property which will then be included within the Crystal View Estates
16 development and will be governed by the Declaration of Covenants, Conditions and Restrictions
17 together with amendments.

21 subjects the real property described on Exhibit "B" attached hereto, together with all
22 improvements and other fixtures of whatever kind now or hereafter located thereon, and all

24 the covenants, conditions, restrictions, liens, assessments, easements, privileges and rights
25 contained in the original Declaration of Covenants, Conditions and Restrictions for Crystal View
26 Estates, together with all amendments as identified hereinabove.

29 3.2 Owners Association. There presently exists a Crystal View Estates
30 Homeowners Association pursuant to the terms and conditions of the original Declaration of
31 Covenants, Conditions and Restrictions for Crystal View Estates. The Crystal View Estates



1 Homeowners Association shall also apply to the property described on Exhibit "B" attached
2 hereto and annexed herein, and the owners of lots within said properties shall be members of the
3 Crystal View Estates Homeowners Association.

5 3.3 Covenants, Conditions, Restrictions and Easements. The Developer,
6 Crystal View Estates, a Washington joint venture, hereby affirms the Declaration of Covenants,
7 Conditions and Restrictions for Crystal View Estates together with all amendments, as being in
8 full force and effect, and said covenants and amendments shall apply with full force and effect to
9 the property described on Exhibit "B" attached hereto.

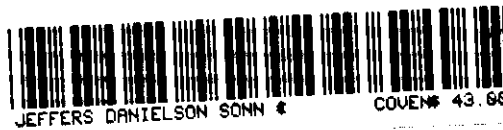

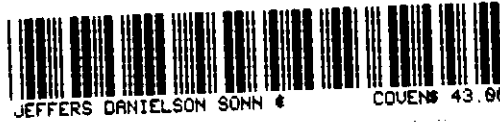
